

Requests for clarification and answers - call for the 4 members of the Management Committee:

Request for clarification no. 1:

Would you accept applications from non-Italian citizens and residents?

Answer to the request of clarification no. 1:

Yes, as admission requirement (within the others listed in the call) it is needed the “*enjoyment of civil and political rights in the State of residence*”.

Request for clarification no. 2:

Regarding the declaration of truthfulness and correctness of data per Presidential Decree No. 445/2000 as well as the responsibility as regards criminal sanctions in case of misrepresentation and forgery, could you kindly provide the full text of this declaration as requested to be made, in English?

Answer to the request of clarification no. 2:

Below, you can find an example of the declaration needed: “*I hereby declare that all the data are true and correct according to the Presidential Decree No. 445/2000, and to be aware of the liabilities applied in case of false declarations as stated by art. 76 of the Presidential Decree No. 445/2000 assuming full responsibility as regards criminal sanctions in case of misrepresentation and forgery (art. 76 of the Presidential Decree No. 445/2000)*”. Please consider that this is a declaration to be included in your CV.

Request for clarification no. 3:

Is the position part-time or full-time? If part-time, how many meetings or days of contribution are estimated to be required during one year?

Answer to the request of clarification no. 3:

It is neither part-time nor full-time, as it is not an employment subordinate relationship. The members of the Committee will be granted a gross annual compensation up to Euros 30.000,00 each, as provided for in the Regulation of the Foundation approved with the P.C.M.D. No. 28/2018; during one year It is required to the Management Committee/its Members the contribution needed to put in place the duties of which it/they is/are in charge of, whose time extent cannot be precisely determined at this initial stage.

Request for clarification no. 4:

Should the CV be produced in Italian or in English?

Answer to the request of clarification no. 4:

It is possible to present it indifferently both in Italian and in English.

Request for clarification no. 5:

I studied abroad (I'm Italian with all the rights) so I thought to include the certified translation instead of inserting the grade in the CV.

Answer to the request of clarification no. 5:

In the call, in the paragraph entitled “**Admission requirements**” it is stated that: “*In order to demonstrate fulfilment of the level and type of experience requested and of the other requirements, the curriculum vitae must include*” [...] the “*grade obtained*” in addition to other information indicated within the same paragraph. The production of the “*sworn translation document*” is not required for the purposes of participation in the procedure, as it is necessary, for the purposes of the assessment, to indicate only the grade. If, however, the candidate deems to attach the “*sworn translation document*” to the CV, its content (grade) must in any case be indicated in the CV itself.

Request for clarification no. 6:

The members of the management committee are either full-time / part-time employees or in a different relationship, for example consultancy?

Answer to the request of clarification no. 6:

The members of the Management Committee referred to in this call will not be qualified as employees, since no employment relationship will be established (neither part-time nor full-time).

The members of the Committee will be granted a gross annual compensation up to Euros 30.000,00 each, as provided for in the Regulation of the Foundation approved with the P.C.M.D. No. 28/2018; during one year It is required to the Management Committee/its Members the contribution needed to put in place the duties of which it/they is/are in charge of, whose time extent cannot be precisely determined at this initial stage.

Request for clarification no. 7:

Is it the English version of the CV the only version acceptable or is it needed also or just the Italian version of the CV?

Answer to the request of clarification no. 7:

It can be attached indifferently the Italian or the English version of the CV.

Request for clarification no. 8:

To submit the application, is it preferable that the CV (and in case the other documents) are in Italian or English?

Answer to the request of clarification no. 8:

The application can be submitted by sending documentation either in Italian or in English.

Request for clarification no. 9

In the registration form in the "description" do I have to give the full title of the qualification in possession for example if I choose in the PhD curtain, after the description, "PhD in Management Engineering" or do you need a more extensive description of the topics treated by the candidate during his doctorate? Another doubt that has come to us is that the description part is completely independent from the field above that is the title of study and that You might need the description of something else. Can you clarify?

Answer to the request of clarification no. 9

For the purposes of a correct and complete submission of the application it is not necessary that particular information are included in the Form, but within the attachments referred to in the call, according to the paragraph "**Submission details and deadline**" shown below for clarification purposes only [...]
